DIRECTIONS FOR USE: Insecto Pro Formula Fly & Wasp Destroyer is a space & surface spray insect killer for use against flies, wasps, moths & mosquitoes. Ensure other adults, children and pets are removed and all windows and doors are closed prior to the treatment. Shake the can well before use. Space Spray: For maximum effect hold the can upright and spray for 10-15 seconds into the air. Keep the room closed for 15 minutes after treatment. Ventilate thoroughly before re-entry. Surface Spray: For maximum effect hold can upright and spray short bursts for approximately 1 second directly at the insects from a distance of 60-90cm.

Do not spray on clothing, bedding (including mattresses) or onto plants.

STATUTORY CONDITIONS OF APPROVAL RELATING TO USE: FOR USE ONLY AS AN AMATEUR INSECTICIDE. Application rate: SPACE SPRAY: Hold container upright and spray for 10-15 seconds into the air in a typical room. SURFACE SPRAY: Spray short bursts of approximately 1 second directly at insects from a distance of 60-90cm.
